# Aging & Disability Resource Center (ADRC)

The purpose of our Aging & Disability Resource Center is to streamline access to public programs and resources with the community. It is the *"one stop shop"* for people in need. We serve individuals regardless of age, disability, or income level. Service needs vary with each individual, so we provide information and resources available within a client's community via an initial needs assessment. The ADRC Information and Referral Services point those in need of help in the right direction in regards to food, financial assistance, access to healthcare, medications, long-term care options, mental health services, transportation and more. Trained caseworkers have an extensive database of information on agencies, services, and programs within the six counties of Cass, Fulton, Howard, Miami, Tipton and Wabash.

## Woman, Infants & Children

The Special Supplemental Nutrition Program for Women, Infants, and Children is a federally funded program that is designed to provide services to low-income pregnant, postpartum and breastfeeding women, along with infants and children up to age 5 who are at health or nutritional risk. WIC provides prenatal education, nutrition education, healthy foods, health screenings, referrals to resources, and breastfeeding support. (Miami & Wabash counties)

## Covering Kids & Families (CKF)

Covering Kids & Families advocates for healthcare coverage for all Hoosiers. We provide community outreach, education and enrollment for Medicaid, Children's Health Insurance Plan (CHIP), the Healthy Indiana Plan (HIP) and Affordable Care Act Marketplace plans. Finding and applying for health insurance can be intimidating and often difficult to navigate, but we help individuals find coverage at a price they can afford and help them to successfully complete the application process.

# Energy Assistance Program (EAP)

The Energy Assistance Program (EAP) is made available to you by Indiana Housing and Community Development Authority (IHCDA), facilitated through Area Five. Energy Assistance Program provides low-income individual and families with a one -time benefit assistance to their electric and heating bills during the winter months, with potential to access crisis funding if they are up for disconnect or already disconnected. They do not pay any deposits, but funding does allow to cover reconnection and connections fees. Clients are routinely provided education on energy conservation. Individuals and families are armed with the tools and information to help reduce their energy use, and in turn, their energy burden.

## Family Caregiver Support



## **Family Support Groups**

An extra hand when you need it, as raising children can be challenging, is what we do. We offer support, networking, education, and coping skills for parents and grandparents raising children. Moms Group (Cass County) and Grandparents Group (Tipton & Wabash Counties) are available, free of charge, to those with kids of any age. Weekly meetings cover topics such as nutrition, health, child development, parenting skills, community resources and more.

## Head Start

Head Start is a federally funded preschool program that provides free comprehensive services to young children ages 3 to 5 and their families in Cass, Fulton & Wabash counties. Eligibility is based on the child's age and the family's income. Parent involvement is encouraged. Classes are Monday through Friday from August to May. Hot breakfast and lunch are provided. Services offered through Head Start include individualized teaching, speech and language, hearing, vision, dental and developmental screenings, and growth assessments. Our teachers track individual and classroom progress in essential domain areas of school readiness goals to show academic and social growth.

### Success Story- Meet Scarlett Gonzalez

She is an Area Five Agency Head Start student who will be graduating high school this year in the top ten of her class as an academic honors student. She will be one of the first in her family to attend college. Scarlett was just awarded the Daughters of American Revolution Good Citizenship Award. Her extra activities include Book Club, Logansport Children's Choir, and Logansport Winter Percussions Ensemble. She founded a new student club called Students Speak. This new group of students volunteered for an adoption event at the local Humane Society, organized a "March for Our Lives" gun control event in our town, participated in the Women's March in Indy, spoke this year in Indianapolis at their Climate Strike, and spoke at a local rally for children of immigration last summer. Scarlett hopes these experiences will help her on her journey to earning a bachelor's degree, and an eventual master's degree, at New York University this fall, where she will be majoring in Public Policy and Environmental Studies. She also hopes to one day start a non-profit business that will help others. Her father joined her in the interview. They added that her big brother also attended our Head Start program here and is also

attending college.

They appreciate that children get a <u>"Head Start"</u> on education in our community.

Scarlett has even agreed to help give back to the Head Start children by helping them with their preschool garden this summer.

## Healthy Families

This program is to support and encourage parents and assist in reducing the stress of parenting so that parents have time to experience the joys of being a parent. We provide the latest information on child development, what to expect as your baby grows and develops, and activities that encourage your baby's healthy development, all at no cost. Community resources are available for families. (Cass, Fulton, Miami & Wabash counties)

### Housing/Development

Our goal is to provide a living environment that is safe, adaptable, and comfortable, increasing the probability that one can remain independent in their home as life circumstances change. Three duplex rental home opportunities, a single family home, and Bend in the Woods, a 48 unit senior housing complex are available in Cass County.

Statistics: We housed 48 senior individuals and seven families last year

### Indiana Minority Health Coalition

This coalition exists to eliminate health disparities through research, education, advocacy, and access to health care services for minority populations. Our focus priorities are mental health, oral health, obesity, and health insurance access. Our coalition participates in ongoing meetings, advocacy efforts, health fairs, and presentations and interventions. Free family-centered activities, valuable information on health goals and insurance options and resources are many of the things we offer our clients.

## Individual Development Accounts

Our IDA program allows you to increase your savings while building your assets with a four year matched savings program, assisting individuals in achieving self-sufficiency through literacy, and with asset development and retention. Funds can be utilized for college or vocational training, starting or expanding a business, purchasing a car or purchasing or repairing your home. Eligibility guidelines apply based on income and household size.

### Legal Services

Our program assists individuals in answering legal questions dealing with issues such as: housing, consumer issues, employment, personal decision making, wills and probate, guardianships, and family concern. There is no charge. While legal representation is not provided, questions are answered and clients are given direction. We partner with the law firm of <u>Michael and Stevenson</u> which provides a lawyer on site five hours monthly who is available to meet and assist clients.





### **Pre-Admission Screening**

One of the goals of services we provide is to assist individuals to remain as independent as possible in their home environment. However, there are times individuals require 24-hour care in a skilled nursing facility. Pre-admission screening is a federally mandated program that assists families in determining the appropriateness of nursing facility placement or whether the individual can remain at home with support from in-home and community services.

## Transportation

For many, transportation is a vital resource, one that allows individuals aged 60 and older to maintain their independence and remain active in the community by providing access to medical appointments, life-sustaining therapies, nutrition sites, social service organizations, banks, employment, shopping, and more. We refer clients in our six county area to the nearest subsidized transportation service available. While there is no charge under our program for riders 60 years and older, donations are welcome. Transportation operates Monday - Friday, and the hours vary by county. Reservations should be made in advance.

### Long-Term Ombudsman

An Ombudsman is an advocate who seeks to resolve complaints made by or on behalf of people who are consumers of long-term care services. They advocate for quality long-term care for our clients, identifying conflicts or concerns, addresses and investigates issues, and works toward resolutions. He works with both individuals and their families to answer questions, provide referrals, and coordinate care from the Indiana State Department of Health, physicians, law enforcement, and Social Services. He also helps when residents or family members have questions and concerns about the rights of older consumers receiving long-term care, quality of care or treatment, appeals regarding transfers, discharges, discontinuance or changes in

services; and billing charges. There is no fee for using the services of an Ombudsman.

### Senior Nutrition

Hot meals are prepared in our commercial kitchen and taken to meal sites or delivered to homes. This program brings together local community members 60 years of age and older to enjoy a nutritious, hot meal, healthy lifestyle activities, an atmosphere for social networking, opportunities for sharing information, entertainment, fun and more. The Farmer's Market vouchers support local farmers by allowing seniors to purchase fresh fruits and vegetables during the summer season.

### State Health Insurance Assistance Program

Counselors assist individuals in answering questions about Medicare, Medicare Supplement Insurance, Medicare Advantage Plans, Medicaid, long term financing options, and prescription coverage. We provide educational materials, a long term care insurance self -assessment guide, and current listings of insurance companies approved to sell various decisions.

policies. We show how to evaluate the various Medicare supplement and long term care and prescription insurance policies currently available. We can help individuals understand and organize Medicare records, educate on how claims are filed, and how to appeal decisions.

### Case Management

Case Managers work with the aged and disabled in our communities via regular outreach and ADRC referrals to help clients stay safely self-sufficient in their own homes versus a long-term care facility. Case Managers assess the needs of the client to determine appropriate services and a funding source to meet the client's needs. Services range from home healthcare, skilled nursing care, respite care for caregivers, housekeeping, durable medical equipment, transportation, personal emergency response systems, home delivered meals, and home modifications such as wheelchair ramps. Funding sources allocated to provide services include: Social Services Block Grant (SSBG), Community and Home Options to Institutional Care for the Elderly and Disabled (CHOICE), Aged & Disabled Medicaid Waiver and Title III & III-E funds.

### Volunteer Income Tax Assistance

We offer free basic income tax preparation with electronic filing in partnership with the United Way of Howard County. We can do federal and state tax preparation and filing for income under \$60,000 for all ages. Individuals receive 100% of refunds with no fees or interest. Drop off necessary information from February through April.
